Blandford Ski Area-Snowsports 6 Week Ski & Ride Programs

This year will hopefully bring us loads of snow! Please note we have quite a few registration changes this season. Ski and board rentals are no longer part of a package. Rentals (skis, boards & helmets) are separate and made payable to Comp Edge, not BSA. All forms have changes. Please do not use past years' forms.

Payments cannot be combined-no exceptions.

Payments for rental must be made payable to the Competitive Edge

Please note:

- Monday night program begins January 9th, Wednesday night program begins January 4th, Friday night program begins January 6th, Saturday program begins January 7th and Sunday program begins January 8th.
- Be sure to make parents, participants & chaperones aware that a weekly lesson is ONE hour.
- Participants cannot switch from skiing to boarding or boarding to skiing once the program has started.
- Program is for ages 6 and up.
- Helmets are recommended, but not required.
- Coordinator receives a complimentary area ticket. One adult chaperone area ticket will be issued for every ten children.
- Transportation to and from the area is your responsibility.
- Sessions cannot be made up unless canceled by the ski area.
- List of chaperones and cell numbers needed before start of program for Ski Patrol.
- All forms and payments are due to BSA by the 17th of December.

Rental fittings are usually required for large groups before the start of the program. The Competitive Edge is ready to serve you! Contact Jim Kennedy at the Competitive Edge by calling 413.538.7662 for specific details.

Monday, Wednesday and Friday night groups can ski/ride the mountain anytime after 3:00pm until 9:00pm. 8:30am until 4:00pm for Saturday & Sunday groups.

Each week chaperones must escort participants receiving lessons to the group's assigned waiting area and remain until lesson begins with instructor. Chaperones can discuss with the instructor where to meet when the lesson has ended. Be sure your chaperones are aware of this.

Here is what the Snowsports Education Center must have by the December 17 deadline:

- **School/Group Registration Form (included below)**
- **Master List/Spreadsheet of participants that includes: name, package, rental (y or N), helmet (y or no), skier or boarder, beginner (y or n), amount to BSA, amount to Comp Edge**
- **Refund Policy & Release of Liability Form for each participant (included below)**
- **Payments in full to the Blandford Ski Area AND Competitive Edge**
- **Drop off or mail forms & payments to BSA, Attn: Sharon Lussier-Snowsports Office, P.O. Box 159, Blandford, Ma 01008**

After the deadline of December 17, any changes or additions will be processed by the Snowsports Education Center. A parent who would like to register their child or change packages after the 17th can contact me directly before the start of the program. Be sure to make parents aware that a \$20 late fee will be applied to the package(s) purchased. Parents who wait until the first day/evening of the start date, a \$35 late fee will be applied to the package(s) purchased.

I hope that is everything. Let me know if your contact information has changed. If you have any questions, concerns, etc., please leave me a message at the ski area or drop me an email. Email would be best.

In some cases a credit may be issued depending on the circumstances to be decided by the director of the Snowsports Education Center. There will be an administrative fee of \$20.00 on these transactions. Please allow 12-14 weeks for the processing of refunds / credits.

I understand that Skiing and Snowboard skiing are hazardous activities, and I accept and clearly understand that there are inherent and other risks involved in the sport of skiing for which this pass is to be used. Those risks include, but are not limited to skier collision with padded and unpadded objects including natural and man-made objects or other skiers, varying terrain, weather conditions, ice, maintenance vehicles and many other hazards. I also understand that increased speed means increased danger and risk of injury. As a condition of being permitted to use the ski area premises, I freely accept and voluntarily ASSUME ALL THE RISKS of any injury or property damage, COVENANTS NOT TO SUE and RELEASE The Springfield Ski Club, Inc., its Board of Directors, employees and agents from any and all liability for personal injury or property damage resulting from negligence, conditions of the premises, operations of the ski area, actions or omissions employees or agents of the ski area or from my participation in skiing at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result. I further agree to HOLD HARMLESS AND INDEMNIFY the above named persons or entity from any and all liability for death and/or personal injury, medical or other expense or property damage to myself or others resulting in any way from my use of the ski area premises. I further agree that (1) any claim, which I may at any time bring for any reason against The Springfield Ski Club, Inc., its Board of Directors, employees and agents, shall be submitted to the jurisdiction of the State of Federal Courts of the Commonwealth of Massachusetts and that no claims or actions shall be brought in any other jurisdiction; and (2) any claim shall be governed by the law of Massachusetts.
